DISCUSSION:

- 1. Continue review of manufacturing facility request for 182 Lincoln Ave., Ryan Natividad -Ryan does not have all the information needed, reschedule to a future meeting
- 2. Review Mountain View cemetery rules and maintenance plan
 - -Do we need to set up a cemetery committee
 - -A handful of graves with rocks/borders which makes mowing difficult
 - -Borders/rocks are not allowed, Town is allowed to remove (Section IV, C, #7)
 - -Public Works is responsible for maintaining, seasonal worker will assist, complaints we have received were during spring/summer months
 - -Kyle will make a list of graves, we will attempt to contact family and give up 180 days to remove borders/rocks
- 3. Salary definition for exempt vs. non-exempt
 - -Police Chief is only employee on salary
 - -Everyone else will remain on hourly pay at this time
- 4. Veterans Park planning layout to include community garden, fencing bids, email request
 - -Panels will cover more area for less money, won't be permanent
 - -Maximize the current garden area, expand to the west
 - -Resident request to add additional baby swing to playground
- 5. Review replacement chair and table racks for gymnasium
 - -Will be nice to have once gym is improved with CDBG grant
- 6. Review ordinance for Town of Nunn tree maintenance and planting
 - -Tree at 2nd and Lincoln Ave. is in right of way, get a quote to remove, hazard
