- -Plant investments and water share update: We are not able to purchase any plant investments until we sign a new water services agreement with North Weld Water. The Town attorney is reviewing the most recent template provided by North Weld on 10/29/2024. We will need to move purchases of water shares and plant investments to 2025. We need to meet with North Weld and Town engineer before we proceed. The additional funding approvals that we were going to need to complete this year from general fund to water fund and additional water fund allocations will have to be utilized by the end of next year
