CALL TO ORDER

The Work Session of the Board of Trustees for the Town of Nunn for May 1st, 2025 was called to order and presided over by Mayor Cable.

Motion by Trustee Buxton and seconded by Trustee's Asher/Kaus to approve the agenda as read.
All in favor, motion carried.

DISCUSSION:

1. Placing flags at cemetery for Memorial Day
 - Public Works to place flags on Thursday before, help is available if they need it
 - Take list of veterans they have and add any names that are missing, thinking about 80 names total
2. Review completed services, final invoice by Quality Well and Pump
 - Expense already approved by the board
 - Everything is up and running to the park
 - Detailed description is helpful for the grant Trustee Asher is working on
3. Review quotes for carpet cleaning at Town Hall
 - Should we wait to see if we are awarded the CDBG grant, and clean carpets after that work is complete
 - We could pay for one clean now and use the RFP for secondary cleaning after repairs
 - Need to have done before Lauren Boeberts representative meet/greet on May 20th
 - Expense is included in the budget, schedule as soon as possible
4. Update for inactive alley way, property owner 1008 Land/David Fader
 - David called in more of an engineer locate
 - Kyle suggests that David call the results of tier 1 list, contact them directly and explain purpose of the locate
 - Verify that Town can vacate a right of way but not a utility easement

- Weld County is beginning their 5-year review of Hazardous Mitigation plan
 - Town plans fall under Weld Counties so Town needs to update their mitigation issues over next 5 years
 - emergency tornado shelter that is ADA accessible
 - siren for east side of town, possible 4 total sirens around town
 - water tower, emergency water source for FD
 - fire mitigation, identify problem areas; fire break on non-active ag property

- Need to increase flag budget for next year
- Do not have dust suppressant scheduled yet
- Possibly move speed box to a different location on 4th Street
