- -New Water services agreement has been provided by North Weld Water; Town attorney is reviewing. Last agreement was back in 2000
- -Weld County Elections will be setting up on June 20^{th} for the election days of June 24-25. They have also requested to use the facility for the November elections
- -I attended webinar for CIRSA town insurance coverage. Deductibles will be increased to \$5,000.00 rather than \$500.00 as a result of losses for the pool. The major losses were for wind and hail damage at 18 million, which is 2 ½ times more than the previous 4 years total. Law Enforcement liability has also increased a great deal. Recent claims have totaled 20 million more than the previous 36 years of claims with CIRSA.

- -Resident Jenny Johnson, are there any requirements for mowing on resident lots, or do we just maintain our own? Per Chief Florence, we are beginning to ramp up on code enforcement, letters will be going out on yard/lot maintenance. If residents to not comply, first a warning followed by a written warning 2 weeks later, then a citation 2 weeks later if necessary. We will consider sending our public works department out to clean up the yard/lot and bill the resident accordingly if multiple citations are issued with no compliance. If a resident displays that they are attempting to clean up their yard/lot and progress is being made a citation will not be issued. Town does not mow right of ways or alleys; they are easements. Our code states that it is the resident's responsibility. Trustee Kelly will reach out to FFA about assisting older residents in town with yard maintenance.
