# **Animal License Application**

### **Nunn Municipal Code**

**6.04.020 Licensing.** Except as hereinafter otherwise provided, any person within this Town owning, keeping, harboring, or having custody of any dog over the age of six (6) months shall obtain a license for each animal in the manner hereinafter specified with a maximum of four (4) licenses or dogs allowed per premises. (Ord. 152, 1997)

A. Application -- Time for Application. An applicant for such license shall apply for a license within thirty (30) days after having begun to keep, harbor, or have custody of, any such dog, or within thirty (30) days after such dog is brought into this Town; provided, however, this requirement does not apply to a non-resident, keeping a dog within the Town for not longer than sixty (60) days. (Ord. 152, 1997)

- B. Application; Contents.
  - 1. An applicant for such license may apply to the Town Clerk. Such application shall be upon forms provided by the Town and shall contain at least the following information: a. the name, address, and telephone number (if any) of the owner;
    - b. The "call name", breed, age, color, and sex of the animal.
- 2. Such application shall be accompanied by:
  - a. A valid rabies vaccination certificate issued by a licensed veterinarian, which certificate shall contain at least the following information:
    - (1) The name, address, and telephone number (if any) of the owner of the vaccinated dog;
    - (2) The date of said vaccination; (Ord. 152, 1997)
    - (3) The date of expiration of said vaccination; (Ord. 152, 1997)
    - (4) The type of rabies vaccine used; (Ord. 152, 1997)
    - (5) The year and number of the rabies tag; (Ord. 152, 1997)
    - (6) The breed, age, color, and sex of the vaccinated dog; (Ord. 152,997)
    - (7) The signatures of the veterinarian administering the vaccine; and (Ord. 152, 1997)

### How to Apply by Mail

- Fill out as much information as you can.
- Select the type of license you are ordering.
- Sign and date the form.
- Calculate the fees using the fee table below. You may license your dog for one year, unless it is less than 6 months old and not spayed or neutered.

#### License fees are nonrefundable.

- Attach a check or money order (not cash) for the total amount due.
