- -Mayor Moon and my meeting with Upstate Colorado was productive as they had numerous suggestions and helps that may assist the Town planning board in evaluation of new business.
- -The ballots approved in this meeting will be forwarded to Weld County for the November 8th election. There will be a charge for each ballot and the Spanish translation for each ballot. Our deadline is September 9th, 2022.
- -The Mayor requested that I research our credit line and credit card issuance, so that each department had a credit card rather than one for all of Town Purchases. I made two trips to Wells Fargo to try and gather information to increase current credit line and increase the account from one card to three. Wells Fargo is not able to accommodate as I have made two trips to a branch in Greeley. They do not have any records for the Town of Nunn when established etc. The

current card and limit were set prior to my hiring. The limit is set at \$2,500.000. This makes it difficult to order anything that may be over that amount. I have talked with Chad Chavies (town accountant) about establishing relationship with different bank in order to work on the credit card account. Since Farmers Bank is not able to provide credit cards, he advised that additional relationship would be necessary. Bank of Colorado (Eaton), has opened savings account for the Town of Nunn. Credit Cards will be the next process. Once new line of credit is established, I will close the Wells Fargo card.
