#### TOWN CLERK REPORT

# Cathy Payne-Town Clerk

- 1. Waste Management enacted a change on the Town dumpster account in October 2021. We have only been charged for overages on this account. Despite attempts to correct the billing, it did not happen until this month. We now have an outstanding balance of \$9562.60. This will be settled this month and future billings should be accurate.
- 2. The online bill pay for water payments has been set up and Candice ran through two citizen payments as a trial this month. We will need to provide announcement with the letter to the residents along with the rate increases and conservation plans for summer months.
- 3. I have included the draft that I sent out earlier for water rates to review under Water/Streets section as I did not receive any emails of comments. I would like to consider lower tier rates as the suggestions from the Work Session of March 5<sup>th</sup> reflect double tier amounts. If families need to garden for source of food due to rising costs, we may only need to increase these tiers 1.00-2.00 for each tier. I will complete the new rate sheet to include all fee changes and then provide a final draft. We can provide one mailing in April to cover rates and conservation plans.
- 4. The Town of Nunn Election Ballots were mailed earlier this week to registered voters. Election Day at Town Hall will be open from 7:00 a.m. to 7:00 p.m. The three election judges will be in attendance for counting and any voting. The Town will provide lunch and payment for services.
- 5. I will be preparing for a CAV visit with the State of Colorado Water Conservation Board to discuss the Town of Nunn participation in the National Flood Insurance Program. We have not had any CAV visits for 11 years. The meeting will be the end of April. Permits within Special Flood Hazard areas issued since 2017 will need to be compiled.

# **POLICE REPORT**

- 1. There are currently two applicants which were offered conditional offers and they have accepted. They have started the process of backgrounds, psychologicals and physicals.
- 2. Chief Smith has had mandatory training with victim advocates and has identified a few procedures that need to be implemented to keep the Town from liability.
- 3. Schedules will be changing beginning April 1<sup>st</sup>. Chief Smith will be working Wednesday through Saturday and Officer Balltrip will be working Sunday through Wednesday until new hires are trained.
