NEW BUSINESS

- 1. Franchise coordination meeting with Hans Rodvik, area manager for Xcel Energy (zone 5)
 - -Hans started in May 2024, previous was Andrew and Ivan
 - -Franchise agreement renewed in 2019, supposed to get together once a year
 - -Per Trustee Smith, Nunn lost power approximately 100 times last year, sometimes majority of town and sometimes pockets, not all wind related, appliance loss has increased
 - -Hans is our advocate for Xcel
 - -Xcel has more safety precautions in place, fire mitigation, settings on lines; does increase outage times Hans can create an information sheet to educate public; he could also present this information to the public
 - -Hans will email updates about outage information in community
 - -Town can complete application for lights, poles for siren, etc.
 - -Hans will touch base with Ivan, pull an outage report for last year
 - -Enrollment for residents requiring back up for medical devices, low-income residents (LEAP)
 - -Nunn Days is a good opportunity for Xcel to engage with community, help with enrollment
