#### **Discussion:**

- Review Solar build request for 251 Cleveland Ave.

   Owner has 2 parcels
   Crossing an easement, need easement permissions
   Running private utilities where public utilities are located (gas, electric, telephone, water)
   Electricity running from one lot to another, potential for having to split in future
   Not mounted on a house but off ground, concern for heat and voltage exposed to the public
   Area around panels needs to be fenced and notify utility companies
   Why panels cannot be mounted on the roof?
   Home owner needs to check with utility companies first, will they allow, then possible variance
- Review request for 302 Nunn Meadows

   Request to build a 40x60 shop/garage on back SE corner of lot, water not available due to moratorium
   Needs to re submit as a variance request, we will include conditions that variance does not include a home, and
   that in future a home would still require water share/tap.
- Brief review of Antelope Run packet for public hearing scheduled May 18<sup>th</sup>, 2023
   Sub division off east side of 29 <sup>1</sup>/<sub>2</sub>, already secured 10 water shares
   All lots are 2.5 5 acres
- Review request for Seasonal Worker
   Employment through Nunn Days if possible
   Funds are available if we re-allocate some items
- 5. Review quote for roller purchase
  -10-hour trial, then available to purchase at \$21,000.00
  -4000 hours on roller
  -Roll every time after we blade, water; good road conditions will last longer
  -After dust suppressant is laid down and we roll, it will help pack down

  - d. Public Works Mayor Cable:

-JB Sittner has offered to help maintain roads, Town attorney has drafted a 14-page contract for board to review -Overfilled dumpsters, those consistently overfilled, move  $2^{nd}$  dumpster to those locations

-Any dumpsters in Town that are not filled on a regular base, move to a busier location?

-Is it possible to meet with Waste Management representative?

-Nonresidents disposing of their trash, are locking dumpsters an option for the future?

e. Public Outreach/Events Committee

-Clean up bushes at base of trees in park, priority on saving the trees

-Mayor Cable provided update on odor complaint from outdoor grow, Ace's Place provided an odor mitigation proposal, again, odor does not occur all year long, only at certain times. We will have to see how the implementation of their new plans effect the odor during this growing season.

-Discharge of water from a different marijuana grow, Town of Nunn marijuana licensing authority approved plans that included retention pond for water. Pond was never constructed, the State (health dept, marijuana licensing) is now involved, gave grow operation until May 23<sup>rd</sup> to rectify before it becomes a major violation. Simply notifying Town of Nunn at this point, no request for any action on our part.
